- CLASSES:** Senior Men, Men Cat 4/5; Senior Women, Women Cat 4/5.  
Junior-men: 9-12, 13-14, 15-16, 17-18.  
Junior-women: 9-14, 15-18.  
Masters: 45+, 50+, 55+, 60+, 65+.  
Non TT Bike Men "A" Open, Non TT Bike Men "B" Cat 5.  
Non TT Bike Women "A" Open, Non TT Bike Women "B" Cat 5.  
In the Non TT Bike Category, riders in this class will compete without Aero Bars or extensions. Disc wheels, spoke covers, and other forms of solid construction "Aero Wheels" such as Trispoke and Spinergy are not permitted. Bicycles shall conform to USAC rules for Mass Start Bicycles. Skinsuits are allowed.

- PRIZES:** Merchandise to top 3 places in each non-junior class.  
Medals to top three in each junior class  
Results will be compiled for all NJBA TT Cup classes.
- COURSE:** An out and back 7.5 mile perfectly flat course with a wide paved shoulder the entire distance. Riders will be required to stay to the right of the white line for the entire distance except the turn-around point.
- FEES:** Junior entry \$20, others \$35 which includes NJBA and USAC surcharges.
